1. Roll Call:

2. Approval of Previous Teleconference Minutes:

Karim pointed out a correction to last month's meeting minutes. Dr. Erin Bell from UNH
will be presenting some of the ongoing research on the Memorial Bridge in Portsmouth,
NH at the next NEBPP meeting in New Jersey. The previous minutes were approved as
written and will be posted online.

3. Working Group Report Outs:

- Rod reported on the progress made by the Bridge Washing Working Group. The resolution to this discussion was to compile a list of best/current practices for the states in the NEBPP. Ed will send a sample or template of a deliverable that could be used to create a document that will eventually be posted on the TSP2 website. John Hooks and Jeff Nome, from Maine, have volunteered to help with the review of the drafts.
- John Hooks noted the SEBPP is pushing to have bridge washing as one of their proposed research project.
- At one time, the FHWA's long term bridge study was considering including bridge washing, but it has been put on the back burner for now.
- John and Tripp are working on the proposed research topics for SEBPP and NEBPP.
- John indicated the Bridge Preservation Expert Task Group (BPETG) from FHWA is in the process of developing a pocket guide to bridge washing which should be finalized at their May 24 & 25, 2017 meeting.
- Ben suggests we keep in contact with the SEBPP regarding bridge washing so that we can work together and know each other's progress on this issue.

4. Research:

• John indicated the best practices for preservation of decks, which is one of the top five research topics chosen by the NEBPP, is also one of the SEBPP.

5. Training:

• Ed commented that training for local agencies is available. If anyone would like to have training done please contact him. Pete Weykamp is one of the presenters.

6. Treasury:

• Budget as of March 2, 2017 was reported (No change from last meeting.)

7. Volunteer Contributions (Last months):

- Ed stated the list of contributions nationally is still at #38 States.
- Ed will send to Ben a list of which States have made their voluntary contribution invoices. The list is also located on the website TSP2.org.
