


- 2. Approval of minutes from August 5, 2020

- iii. John is looking for a state in the Southeast that uses sealers on bridge decks to participate on the sealers panel discussion. John is requesting the participant to put together a few slides covering what state's practice is on applying sealers on bridge decks.
- iv. John had a discussion with Judy this morning on announcing the schedule to state DOTs. John will be sending an email to SEBPP state participants to distribute registration information further.
- v. John discussed challenges with reaching Ricardo Duarte for the Contracts session. Jeff Pouliotte offered to present and fill the presentation spot. Jeff Pouliotte will coordinate further with John and finalize Contracts session.
- 4. Update on survey for Funding Local Agency Bridge Preservation Projects by John Hooks
 - a. John provided an update on survey response from effort led by Travis Kinney and Gregg Freeman.
 - b. Group has had 327 responses from 27 states. Below are findings from this survey that were briefly discussed.





- c. Survey will be open until September 15th
- d. Participation from states in the southeast has been low. John will be sending a reminder to states to relay to local agencies.

- 5. Roundtable Discussion on Modular Joints Frequency of problems, maintenance, replacing, etc.
 - a. Steven Austin started discussion by noting that Texas has had issues with performance of a modular joint on a major bridge. Steven was curious what other states are doing on bridge maintenance.
 - b. Jeff Milton shared that Virginia has had issues with Transflex joints.
 - c. Mike Hill shared that Arkansas has a bridge with 10 modular joints. With complexity of joint, Arkansas does not want to attempt repairs in house.
 - d. Tim Sherrill shared that North Carolina has a wide range of modular joints that have been in service for 20 or 30 years. No regular maintenance is performed on these joints but would replace glands. North Carolina does not have plans for many of these joints and is looking at other joint types to replace modular joints.
 - e. Jeff Pouliotte shared Florida looks at routine inspection and tries to schedule replacement as a group of joints as they start to deteriorate before it is a critical issue. Florida has tried to eliminate joints and avoid modular joints. District has a feasible action committee that makes recommendation for priority repairs from 1 to 4. FL gives special attention to bridge joints.
 - f. Daniel Muller gave his experience from North Carolina. Daniel believed that a recent bridge in NC with a modular joint had a maintenance plan and was interested in seeing one. Steven shared that D.S. Brown has said that they had a maintenance plan but has not shared it.
 - g. Dick Dunne reminded folks about the Scan team report 17-03, "Experiences in the Performance of Bridge Bearings and Expansion Joints Used for Highway Bridges." Dick will send to Steven to include in meeting minutes.
 - h. Jeff Milton noted that Virginia's policy on new bridges is to only have joints if absolutely necessary. Virginia prefers finger joints noting that Virginia prefers these over modular. Jeff Pouliotte and Mike noted that Florida and Arkansas do have finger joints.

- i. Mike Hill asked about state forces performing repairs to modular joints. Tim replied that they had tried but hadn't had very much success. Ed Welch said that New Hampshire had done some maintenance that would last a couple of years for short term repairs.
- j. Tim asked about condition of beam ends and caps at finger joints. Jeff Milton noted that this was problematic and could be mitigated somewhat with troughs. Jeff P. noted that the few finger joints that Fl has used do have troughs although Florida does not have the problem with deicing chemicals. Jeff Milton noted that troughs do require fairly aggressive maintenance program.
- k. Several states agreed that joint elimination is preferred when possible.
- l. 41:30 Bill Oliva from Wisconsin DOT inquired about discussion on how Florida eliminates joints. Jeff P. noted that in soft soils joint elimination is more difficult to make work because substructure would have to be anchored into rock.
- m. Tim noted that North Carolina has had some success with Transflex for repair material. Jeff P. noted that Virginia has disallowed Transflex joints. Ed Welch noted that New Hampshire would have replacement segments for joint rehabilitation in stock and ready for installation.
