## 2021 Meeting

John: We are planning on combining the Midwest and West meeting for December 7-9, 2021. Planning on joint agenda planning call on the third Wednesday of each month at 2 pm eastern. Combined agenda of both groups, hoping to include most of the presentations that were already planned. We are looking at half days Monday and Thursday. Full days on Tuesday and Wednesday. Probably increase the attendees by 25%. John and Darlene are going to discuss with venue about getting additional space for our

meeting. The half day meeting on Monday, might be an industry focus. A rough agenda was sent to the agenda planning group for both the Midwest and West groups.

V. Technical Topic: Split Timber Girder Repair – Natasha Butler, Colorado DOT Many timber bridges within CDOT's inventory exhibit split timber girders. These split girders lead to issues such as reduced superstructure capacity (requiring load posting or limiting freight trucks), repeat maintenance for the splits and related deck issues, and once 25% of the girders are split, the superstructure is downgraded to an NBI rating of 4, placing the structure in Poor condition. CDOT's current repair method is a lag screw repair, and it has been found that this repair does not provide adequate strength or stiffness to eliminate the potential of progressive splits occurring in the girders adjacent to a split girder. We challenged our designers to work with our maintenance crews to develop a new repair method that could be turned into a worksheet and applied at a statewide level to address the issue. This presentation will discuss the designs that CDOT implemented via a pilot project on a 3-span timber bridge, including lessons learned and next steps for repairing our split girders at a statewide level.

### Discussion:

Thad: Attaching sister beam to existing girder.

Natasha: Attaching through bolt at mid span.

Thad: That answers variance and thermal expansions.

Herb: Sounds like you prefer the sister beam method?

Natasha: Turning out to be cheaper than the incline lag repair. Like the simplicity of the load rating. Pretty confident with the performance long term. After they do the proof test, they will get another data point for the incline lag repair. Maybe revisit design to make it easier and more affordable.

Dick Dunne: Did you think about bunding these to a contractor.

Natasha: They are looking at that right now. They have some funding to repair these structures statewide. The regions in Colorado are determining which ones will be done by contractors or maintenance staffs. Chris Davis: Did you engage with industry on FRP?

Natasha: She believes the designer did most of the research on his own. They did not reach out for help on the design.

Chris Davis: Will reach out to Natasha to see if he could help to get a better experience with FRP on timber structures.

Chris Long: Caltrans repairs for sister beams, meant to get back to original load limit. What do other states do?

Herb: No timber bridges on state system.

Thad: No timber bridges on state system.

Natasha: Got details from Oregon on their timber bridge repairs. One state uses stirrups for their timber repairs.

Chris Long: Good idea to see what works best for these bridges.

### VI. NEW BUSINESS:

Western Forum on Bridge Inspection Issues: Chris Keegan and Evan Grimm. Evan sit in on the southeastern states bridge forum bridge inspection issues. The Midwest is starting their own group. Are other states interested in forming a western group?

Evan: Would be interested from Washington.

Brandon: Would be interested from Nevada.

Herb: Will check to see if there is interest from Idaho.

Chris: Looking for a Champion on this. Set up a meeting to see the interest in the west.
