IV. Technical Presentation - External Post Tensioning of Structures Using CFRP Composites - Eri Vokshi and Marcel Rey

External post-tensioning of structures is a well-established and understood strengthening method for bridges, buildings, and industrial structures. Fiber reinforced polymers (FRP) are a proven technology for upgrading and strengthening concrete, masonry, timber and steel structures. FRP systems can also be post-tensioned to provide active strengthening. This presentation will describe successful installation of external post-tensioned FRP systems, anchoring methods, and design considerations. Typical applications of this strengthening method include flexural reinforcement, seismic upgrades, change in use, and building alterations.





Andrew B: With CFRP system being external, are there issues with the system being UV stable?

Marcel: We recommend the same protection as with plastic. If the system is installed under the bridge, we recommend coating it with Sikaguard 670W.

Chris Long: How about Fire Resistance? Any studies on Fire Resistance? Suggestions on providing fire protection (coating/cover) that still allow "visual" inspection.

Marcel: We have installed the system in some high-rise buildings. The system itself is not fire rated. We recommend installing fire protective plates, which can be removed for visual inspection or mortar if visual inspection isn't necessary.

Eri: If fire resistance is a concern, the FRP should be considered sacrificial.

Chris Long: Do you have any cost estimating information?

Marcel: It's difficult to say because it depends on the length. But if you have a specific project in mind, you can send us a sketch and we can provide a rough estimate.
