#### IV. Technical Session – George Hearn, University of Colorado

Presents AASHTO Guide to Preservation of Highway Bridge Decks.

George says they produced two guides. The bridge preservation actions and deck preservation guide. They worked with T9 to develop the guides. NCHRP funded the guides.

The project started in 2015. The deck guide was published in January 2023. This guide mostly covers steel reinforced concrete decks because that's what most owners are interested in. 96% of NBI deck area is steel reinforced concrete. The guide has some content on timber decks and steel grid decks but it's minimal. This guide is for decks in service.

The deck preservation guide has 5 sections and three appendices. SECTION 1: INTRODUCTION, SECTION 2: PRESERVATION TREATMENTS FOR BRIDGE DECKS, SECTION 3: EVALUATION OF BRIDGE DECKS, SECTION 4: SELECTING PRESERVATION TREATMENTS FOR BRIDGE DECKS, SECTION 5: COSTS AND BENEFITS OF DECK PRESERVATION, APPENDIX A: PRESERVATION TREATMENTS FOR HIGHWAY BRIDGE DECKS, APPENDIX B: DEFECTS IN HIGHWAY BRIDGE DECKS, APPENDIX C: SELECTION OF PRESERVATION TREATMENTS FOR BRIDGE DECKS

George states the AASHTO definition for bridge preservation as "Actions or strategies that prevent, delay or reduce deterioration of bridges or bridge elements, restore the function of existing bridges, keep bridges in good condition and extend bridge life. Preservation actions can be preventive or condition driven." George relates the guides to this definition. Preservation actions in the guide include surfacing, crack sealants, repairs of spalls, deck overlays for a total of 18 preservation treatments. The guide relates conditions to actions. It relates bridge element information to the actions. Deck preparation is addressed in the guide. Discusses test sections. Discusses worker safety. It has examples for conditions required to choose the preservation action. It has present value costs and benefits. There will be follow-up workshops on the two guides this year or next year.

Q&A

Dick Dunn – You show superscripts in the deck perpetration tables?

George Hearn – Footnotes provide clarification. Some footnotes refer you to an applicable article. One is about curing time varying based on temperature. Another states it's important to remove weakened and contaminated concrete.

Dick Dunn – Does guide talk about what to do with reinforcing steel, when to engage? Epoxy coating?

George Hearn – Yes it does, I'll touch on three areas. If bar is partially exposed it discussed when is it great enough to remove the concrete. Depth of penetration of corrosion is there loss of section and when should bars be overlapped and what additional concrete removal is necessary. It recommends to repair damage to epoxy coating bar.

Brandon Henning – Will the workshops be online or in person?

George Hearn – They will be in person workshops. It will be like a WBPP meeting. Will also be web-based materials. Will have slides, someone talking and exercises. Will be an executive session.
