## IV. Technical Session – Tim Woolery

Presents on Alkali-silica reactivity (ASR) identification and mitigation

ASR is a chemical Reaction at which reactive aggregates and moisture in the concrete create a gel like substance that causes hairline cracking on the surface.



#### Q&A

Brandon – So silane is good option for ASR issues?

Tim – Yes because finding aggregates that don't cause ASR is difficult. With ASR you take one element out and you no longer have ASR. Applying silanes keeps the water out and then there is no chance for ASR.

Andrew Pack – How do other states deal with ASR. Idaho uses silanes mostly on barrier. Brandon Henning – We use silanes in southern Nevada for bridge decks and polymer overlays in the north where we get more snow.

## V. <u>New Business – Brandon Henning:</u>

Brandon Henning – Looking to do a workshop on multi hazard considerations for safe, secure and resilient bridges and other transportation infrastructure. Looking for people to give presentations or have information or case studies for the group to use for the workshop. If people are interested contact Nancy
